**Section 4 First aid measures****4.1 Description of first aid measures**

**8.2 Exposure controls**

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration.

**SKIN PROTECTION**
